Cookies policy

Through this policy, we would like to explain what cookies are, which ones we use on https://www.mirai-advisory.com (hereinafter, "MIRAI") and for what purpose. Therefore, take your time to read it, because for us it is important that our users are informed and navigate our website with full knowledge of its characteristics.

1. What are cookies?

Cookies are files that are downloaded to your device when you access certain web pages such as ours, which collect information to ensure the operation and the best possible provision of the services of the website, recognize you as a user, and obtain information about the navigation of users such as the number of times the page has been visited by users or their browsing preferences. They also make it possible to guarantee the user's session while browsing the site and to detect errors in the functioning of the site.

The specific uses we make of these technologies are described below.

2. What types of cookies do we use at MIRAI?

Below, we provide information on the types of cookies we use in MIRAI according to who manages them, their purpose and duration.

2.1. Depending on the entity that manages the device or domain from which the data obtained is sent and processed:

- We use our **own cookies**, that is, those for which we at MIRAI are responsible, and which are sent to your device from a device or domain managed by us and from which we provide you with our service.
- We use **third-party cookies**, for which the parties responsible are entities other than MIRAI, and therefore are sent to your device from the device / domain of said third party, which is the one who processes the data obtained through them.

2.2. Depending on the period of time they remain activated in the terminal, we use:

- **Session Cookies:** these are those designed to collect and store data while you access our website, and disappear at the end of the session.
- **Persistent Cookies:** these cookies remain stored on your device from a few minutes to several years, and therefore the information extracted through it can be accessed and processed for a longer period of time by the responsible.



2.3. Depending on the purpose for which they are used, we use cookies:

- With a **technical** purpose, that is, they are those that allow you to navigate through our website, as well as the use of the different options or services that exist in it, including those that we use to enable the management and operation of the Website and enable its functions and services.
- With an **analytical**, **analysis or measurement purpose**: they are those that allow its responsible to monitor and analyze the behavior of the users of the websites to which they are linked, in order to introduce improvements based on the analysis of the usage data made by the users of the service.

4. Who uses such cookies?

The information collected through the cookies of a web page can be used both by MIRAI and by a third party that provides us with the service of analysis of the Web Page (Google.com) as we have indicated above.

5. How can I manage the cookies settings?

Taking into account the information provided through this Cookie Policy, below we provide information on how you can manage the cookies used through the different options offered by the most common browsers (Explorer, Firefox and Chrome). It should be noted that blocking all cookies may disable certain services and functionalities of the Website.

5.1. How to disable or delete cookies through our cookie settings center

You can accept or reject the use of cookies through our cookie settings center, which you can access both through the basic cookie information banner that appears when you first visit the Website, as well as through the space at the bottom of the page called "Cookie settings".

In our cookie settings center you can consent to the use of cookies, as well as withdraw your consent to their use at any time and as many times as you wish.

Please note that if you accept third-party cookies, you should delete them, if you wish, directly through your browser's cookie management options.

5.2. How to disable or delete cookies through your browser

To disable, restrict, block or delete cookies, the user must modify the settings of the browser you use on your device. In general, browsers offer the following configuration options in relation to the installation of cookies:

- The browser rejects all cookies and, therefore, that no cookie from any web page is installed on your terminal.
- The browser warns you before the installation of the cookie so that you can decide whether or not to accept its installation.
- The browser only rejects third-party cookies from the websites you visit, but not those used by the website you are browsing.
- The option of browsing in private mode by which cookies are installed on the terminal, but is automatically deleted when you finish browsing the website:
